





WORKFORCE DEMOGRAPHICS

EDUCATIONAL ATTAINMENT




San Diego ranks 8th in educational attainment and 4th for most STEM/ STEM-related majors. In San Diego, a relatively high proportion of those with at least a Bachelor's degree hold one in STEM/STEM-related fields. This fosters continuous growth potential in high-demand occupations.

VETERANS AND WOMEN IN THE WORKFORCE



San Diego has a higher percentage of veterans in the workforce than any of its major competitor metros. At 89.1 percent male, the makeup of San Diego's armed forces and transitioning veterans likely explains San Diego's low representation of women in the workforce.


California's rank among seven state tax climates.

CALIFORNIA HIGHEST OVERALL STATE TAXES




BUSINESS OWNERS

San Diego ranks 6th highest for woman-owned businesses, and 5th highest for veteran-owned businesses.

San Diego ranks 2nd in number of small employers (fewer than 10 employees).



MEDIAN HOURLY WAGES



Among the competitor metros, San Diego ranks 7th for highest median wages at \$19.12 an hour. The lowest median wage is in Raleigh, NC at \$17.46 an hour, while the highest median wage is in San Jose, CA at \$28.32 an hour.
