# PROPOSITION 16: REPEAL PROPOSITION 209 AFFIRMATIVE ACTION AMENDMENT

**POSITION:** The Chamber's Public Policy Committee voted to SUPPORT the proposition on August 11, 2020. The Chamber's Board voted to SUPPORT the proposition on September 24, 2020.

**RATIONALE:** Repealing California's ban on affirmative action will increase opportunities for marginalized groups in public education, state contracting, and hiring practices.

**STATUS:** Proposition 16 is the result of Proposition 209 which passed by voters in 1996. Proposition 209 amended the California Constitution to prohibit discrimination or preferential treatment on the basis of race, color, sex, ethnicity, or national origin in public employment, public education, and public contracting. Prop 16 was on the November 3, 2020 ballot and had failed to pass.

### SUMMARY

Proposition 16 repeals Proposition 209 which banned the use of affirmative action. Proposition 16 would allow the state government to reinstitute programs that prioritize women and minority owned businesses in public contracting. Proposition 16 would expand opportunity in education, employment, and pay for women and minority communities. Proponents of the proposition find that passage would allow more targeted achievement programs, such as STEM programs for girls and mentorship programs for students from minority communities. Currently these types of programs are not allowed in public schools. Supporters say it would also help decrease the wage gap women face, specifically women of color.
